### I. Old Business – Len Hoey and Ralph Thompson

- a. Stimulus money update encouraged to visit NC SEO website for updates
- Performance Contracting Updates: UNC-Chapel Hill has not yet submitted application; ECU application received; NC DOT on hold until Energy Manager position is filled
- c. Len continuing to work on paperwork for application of ARRA funds to pay 3<sup>rd</sup> parties on performance contracts. Also, SEO budget has been approved.
- d. Jim Lora at SBO is retiring. Adam Brueggemann to take over Jim's responsibilities.

- e. Tim G. SCO now requires DD's as part of IGA submission. Verbal definition of DD includes plans that identify fire-rated walls and new penetrations. This will add cost and time to IGAs. Len working on making this process as prescriptive as possible.
- f. Tim noted that at 12/10/09 meeting with GA, they were possibly interested in changing the preliminary selection process. Len noted that this may require a change to the statute and that we should focus on working with the current legislation and continue to streamline processes within the present legislative boundaries.
- g. Tim discussed experience with SBO and State Treasury regarding UNCW approval. Construction period interest and asset life were two issues he was working through.
- h. Len discussed that a 60-90 day rate lock was required for NCSU PC financing. This may add 30 basis pts to the rate.
- i. John Hobbes has stepped down from the PC Process Improvement committee. A new Chair will be selected shortly.
- j. Tom Hunter is willing to work on this committee on behalf of the Community Colleges.
- k. Len noted that most recent RFPs for state agencies & UNCs have not varied much from the original templates.

### **II. New Business**

- a. Cindy Brewer suggested a Golf Outing fundraiser for the ESC Chapter. Candidates for hosting the event included Crooked Creek near Fuquay. Greensboro, Burlington and Pinehurst were also mentioned as possible locations. Dates were discussed include Friday 4/23 after the NC Sustainable Energy Conference. No dates or places firmly decided yet. Cindy will need volunteers to help setup the event.
- b. Cindy also discussed having an ESC reception in the afternoon or early evening at the 4/21 NC Sustainable Energy Show.
- c. Tom Hunter asked about inclusion of renewables in PC. Len state that were not many to date. Tim G. pointed out that there are daylighting measures in the UNCW scope at this time. Tom suggested a meeting agenda item to discuss how renewables can be incorporated into PC.
